Mr. Rivet,

Further to our telecom of March 31, 2003, I write to request a meeting with Mr. Guerin, Vice-President and the Chiefs of the Mi'gmawei Mawiomé. As noted in our conversation, the meeting will be scheduled during the first two (2) weeks of May in Quebec City, a specific date to be mutually confirmed.

The Mi'gmaq delegation will include, although may vary at the time of the meeting are; Chief John Martin, Chair of the Mi'gmawei Mawiomé, Co Chairs Chiefs Allison Metallic and Richard Jalbert, legal counsel Franklin Gertler, Council and Negotiator Richard Gray and Executive Director Brenda Gideon Miller.

The objective for this meeting is to discuss the Mi'gmaq interest over Gespegewagi territory in respect to your oil and gas explorations in the Gaspésie Coast. It is our expectation that a mutual understanding will evolve from this meeting and that a plan of action can be mutually addressed. I outline for your reference a proposed agenda as follows:

- Mi'gmawei Mawiomé orientation – Chief John Martin
- Measures for accommodation of Mi'gmaq interest in lands, waters and resources (including Mi'gmaq role in decision making, joint ventures, contracting (set aside), employment, revenues, training).

Specific files:

- a) Oil & Gas exploration - on land and underwater.
