# Monitoring Report Smart Meter Investment – September 2010

# March 3, 2011

### **Purpose and Objective**

On October 26, 2010 the Board issued a letter to all licensed distribution companies (distributors) requiring distributors to file information about smart meter investments on a quarterly basis. This report summarizes the life-to-date investments by distributors with respect to the implementation of smart meters up to September 30, 2010.

### Background

In 2004, the Minister of Energy asked the Ontario Energy Board to develop an implementation plan to achieve the Government of Ontario's smart meter targets for electricity: 800,000 smart meters installed by December 31, 2007 and installation of smart meters for all Ontario customers by December 31, 2010. The Board consulted with industry and completed the *Smart Meter Implementation Plan – Report of the Board to the Minister (2005).* The Board's report stated "the total capital cost through to 2010 for the proposed system (meter, communications, installation and distributor system changes) is estimated at \$1 billion."<sup>1</sup>

Some distributors began installing smart meters as early as 2005. By 2006, there were 351,062<sup>2</sup> meters installed in the province. As of September 30, 2010 there were 4,382,194<sup>3</sup> meters installed. Distributors have been reporting to the Board on their progress installing meters since June 2009. The Board's monitoring reports on smart meter and time-of-use implementation provide more detail about smart meter installation across Ontario. Overall, the majority of installations took place between the third quarter of 2009 and the end of 2010.

In 2009, the Board's Regulatory Audit and Accounting staff conducted an electricity distributor sector smart meter audit review for the period of January 1,

2006 to September 30, 2009. At the time of the audit review the meter installation was 64% complete with 3,053,931 meters installed. The results of the review showed the total investment at that time was \$633,294,140 or about 64% of the total estimated cost of the program (as outlined in the Board's Report to the Minister).

The Board followed up on this review, on October 26, 2010 and issued a letter to all distributors requiring them to provide information on their smart meter investments on a quarterly basis. This report provides a summary of the first of the distributors' quarterly updates. These results represent the life-to-date investments in smart meter implementation as of September 30, 2010.

# Summary

- As of September 30, 2010 the total provincial investment in smart meter installation was \$994,426,187.
- As of September 30, 2010 smart meter installation was 94% complete with 4,382,194 meters installed.
- This figure is consistent with both the Board's original estimate in its 2005 Report and the findings and projections resulting from the 2009 audit review. It should be noted, that since 2005 the number of eligible customers in the province has grown from 4,475,937<sup>4</sup> to 4,683,202<sup>5</sup> as of September 2010.
