# Summary of Business Accomplishments

Ms. Snyder has twenty years' experience in the energy industry, with varied and growing responsibilities covering North American and global natural gas markets.. At Wood Mackenzie, Jen is responsible for the content and research agenda for the North American Gas Service. The service was launched in 2003 under Ms. Snyder's direction. Currently, 112 companies subscribe to this retainer service, including ten clients in the Fortune 100, and 14 government or publicallyowned energy companies.

As part of the service, Jen directs the biannual publication of the US and Canadian Long Term Outlooks. These reports include forecasts for supply, demand and price forecasts for regional and national natural gas markets, as well the economic, policy, and energy landscape influencing those forecasts. Wood Mackenzie's client companies rely on these publications for strategic planning purposes, regulatory filings, and market intelligence.

In her role as Principal Analyst, Jen has presented to the Board of Directors at utility, public energy, major North American pipeline & North American and global upstream exploration and production companies ten times in the past four years.

For the past five years, Jen has served on the Advisory Council at the Electric Power Research Institute, Inc. ("EPRI"). EPRI conducts research, development and demonstration (RD&D) relating to the generation, delivery and use of electricity for the benefit of the public. This independent, nonprofit organization brings together scientists and engineers as well as experts from academia and the industry to help address challenges in electricity. EPRI's work spans nearly every area of electricity generation, delivery and use, management and environmental responsibility. For the past two years, Jen has served on the Executive Committee of the Advisory Council.
