2. Blackstone is a consulting firm working in the field of information technologies and has been retained by Gaz Métro in order to develop the project described in Exhibit B-0005;
3. I have personal knowledge of the facts relevant to the request for a confidentiality order filed on October 9, 2015, by Gaz Métro;
