- 6. I have also prepared with Brando So the evidence presenting the results of the Fully Allocated Cost Study reflecting the proposed changes to the allocation of Mains Capacity-related costs to the customer rate classes for the 2018 test year;

- 8. I have also prepared with Jackie Collier the evidence addressing the proposed 2018 distribution rates based on the results of the proposed change in allocation of Capacity

costs to customers within the 2018 proposed fully allocated study as well as the evidence addressing the derivation of the distribution and gas costs rates for 2018 incorporating the proposed change in the allocation of Capacity costs and corresponding proposed distribution rates;
