Dear colleague,

We represent Summitt Energy Quebec LP / Énergie Summit Québec S.E.C. (“**Summitt**”), which was granted intervenant status in the above-captioned file by decision D-2018-109. We made representations on behalf of Summitt during the hearing of September 4, 2019.

In its letter filed in the above-captioned matter as R-4008-2017-B-0035-DemInterv-Comm-2018_06_22, Énergir indicated: "*dans l'éventualité où la Régie accueillait la demande d'intervention de Summitt Energy, ou de tout autre intervenant pour lequel l'anglais est la langue d'usage, Énergir souligne qu'elle est disposée à procéder à la traduction de la preuve versée au dossier. Énergir soumet par ailleurs que si une traduction doit être faite, il serait alors préférable que celle-ci vise l'ensemble de la documentation versée au dossier*". On August 27, 2018, counsel for Énergir confirmed that Énergir would take the necessary steps.

Notwithstanding the above, and despite that we had been registered for the electronic filing system (“**SDE**”), we have not received any emails from that system since October 12, 2018, were not made aware of the March 13, 2019 decision D-2019-031 scheduling a hearing for May 7 and 8, 2019, and we received no proceedings, communication or evidence (translated or otherwise) relating thereto. Summitt was therefore prevented from participating in that hearing, and we still have no access to the SDE. It was only by receiving an email directly from another


intervenant on June 6, 2019 that we were made aware that there had been developments in the file.

We are presently reviewing the publicly available documents to determine whether any matters were addressed at the recent hearing regarding which Summitt would have made representations. We are also waiting to receive access to the SDE in order to be able to review the confidential documents contained therein. We have also left a message with counsel for Énergir to determine whether any translated documents have been prepared as agreed.

In view of the above, we reserve all of Summitt's rights and respectfully request that no decision be rendered by the Régie in the above-captioned file until such time as Summitt has had an opportunity to make written representations.
