APPLICATION FOR AUTHORIZATION TO PROCEED WITH INVESTMENTS RELATING TO THE OPTIMIZATION OF THE POINTE-DU-LAC AND SAINT-FLAVIEN SITES AND APPLICATION FOR THE CONSTRUCTION OF A PIPELINE (DOSSIER R-4157-2021)

The Régie de l'énergie (the Régie) will study the application by Intragaz, limited partnership (Intragaz), relating to an investment to optimize the Pointe-du-Lac site (the **Pointe-du-Lac Project**) and the Saint-Flavien site (the **Saint-Flavien Project**) in order to increase their withdrawal capacity (the **Application**). The costs for the Pointe-du-Lac and Saint-Flavien Projects are estimated at \$16.5M and \$10.2M respectively.

The Pointe-du-Lac Project requires the installation of network connection lines for five existing wells and an increase in the diameter of collection lines connected to six existing wells.

A pipeline construction project must be approved by the Minister of Energy and Natural Resources. The *Petroleum Resources Act*¹ provides that a person seeking such an authorization from the Minister must first submit his project to the Régie and obtain a favourable decision. The Régie will examine Intragaz' specific request regarding the construction of a pipeline as part of the present file.

The application relating to the construction of a pipeline is submitted by virtue of Sections 118 and following of the *Petroleum Resources Act* and of sections 118 and following of the *Regulation respecting petroleum exploration, production and storage licences, and the pipeline construction or use authorization*².

REQUESTS FOR INTERVENTION

In conformity with Decision D-2021-063, an interested person wishing to participate must be granted intervenor status. A request for intervention must be forwarded to the Régie and Intragaz **by June 2, 2021, at 12:00 noon**, and must provide all the information mentioned in this decision and those provided for by the *Rules of procedure of the Régie de l'énergie*³, the text of which is available on the Régie's website.

Intragaz may comment the requests for intervention **by June 8, 2021, at 12:00 (noon)**. Responses to these comments are to be filed **by June 10, 2021, at 12:00 (noon)**.
